OFFICIAL RULES AND REGULATIONS

(the “Promotion or Sweepstakes Rules”)

The “Summer Of Discovery” sweepstakes (the “Promotion or Sweepstakes”) is organized by The Saint Lucia Tourism Authority. «SLTA» (the “Organizer”). The Sweepstakes begins on Friday, June 1st, 2018 at 9:00 a.m., AST (the “Sweepstakes Opening Date”), and ends on Sunday, September 30th, 2018 at 11:59 p.m., AST (the “Sweepstakes Closing Date”).

The Sweepstakes (the “Promotion” or “Sweepstakes”) is open worldwide (Excluding Saint Lucia) for individuals who are at least eighteen (18) years of age at the time of entry (the “Entrants”). (The “Promotion” or “Sweepstakes”) is not open to employees, agents, mandataries and representatives of the Organizer, its subsidiaries, affiliates, affiliated companies, advertising or promotion agencies, the suppliers of material, prizes and services related to this Sweepstakes, and any other stakeholder directly related to the holding of the Sweepstakes, as well as the members of their immediate family (father, mother, brothers, sisters, children and legal or de facto spouse) and anyone with whom these employees, representatives and agents reside.

2. **HOW IT WORKS – PROMOTIONAL RULES**

HOW TO PARTICIPATE

To enter the Sweepstakes, the entrant (the “Entrant”) must:

- Follow **@travelsaintlucia** on Instagram

- Visit a minimum of 5 pre-defined locations and capture a selfie at that location.
 - Take one selfie at your hotel
 - Visit a minimum of 4 iconic locations on the island.
 - Choose from 25 locations.
- Post your photos with the hashtags #saintlucia, #summerofdiscovery and the hashtag for each location (sign with location-specific hashtags found on premise)
- Tag @travelsaintlucia in the photo
- That's it! Winners will be notified via DM on October 8th 2018!
- Promotion runs June 1st–Sept 30th 2018
- For every location based selfie posted beyond the minimum 5 –the user will get an extra entry in the sweepstakes.
 - For example, user visits 15 locations , they will get 11 entries in the sweepstakes

HOW IT WORKS – USER EXPERIENCE

- Photo sweepstakes entries automatically get added to a gallery that shows photo captions and entrants.
- Collect photos using hashtags.
- Require email address or Facebook login for entries.
- Enable Facebook Share
- Auto-approve entries, or moderate submissions before they appear in your Instagram/Facebook gallery.
- Limit the number of entries from each entrant.

3. GENERAL CONDITIONS

- By entering the Sweepstakes, the Entrant acknowledges

having read and understood these Rules and agrees to be bound by them and to comply with them. The Entrant declares that the Rules are understandable and reasonably available for consultation.

- The Organizer reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Grand Prize using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Organizer reserves the right, at its sole discretion, to disqualify any individual deemed to be: (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Organizer's Website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

- The Organizer will not be held liable and assumes no responsibility for any error, omission, technical malfunction, loss or fault relating to operation or transmission, failure of communication lines, loss or destruction or prohibited access to or modification of the entries. The Organizer is not responsible in any way for erroneous or inaccurate information, whether caused by

website users or by the equipment and/or programs associated with or used by the Sweepstakes or by a technical or human error that may have occurred in conducting the Sweepstakes, including in the processing of entry forms. The Organizer is not responsible for any injuries or damages that may result from the holding of the Sweepstakes. All forms become the property of the Organizer and will not be returned to the Entrants. The Organizer reserves the right to destroy all the documents pertaining to the Sweepstakes once the retention period as required by law has expired.

- The Organizer reserves the right, at its sole discretion, to cancel, modify or postpone the Sweepstake at any time, without prior notice, if any factor prevents the holding of the Sweepstake pursuant to these Rules or in accordance with any law, regulation, by-law or policy of any entity having jurisdiction over the Organizer.
- As a condition of participating in this Promotion, entrant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Promotion, shall be resolved individually, without resort to any form of class action, exclusively, before a court having competent jurisdiction, which Court shall apply the laws of United Kingdom without regards for doctrines of Conflict of Law. Further, in any such dispute, under no circumstances will entrant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, nor consequential damages, or any other damages, including attorney's fees, other than entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
- The Promotion is subject to all applicable laws, federal, provincial and municipal laws, regulations and by-laws in the various countries where the Sweepstakes is valid.

4. DRAWING AND NOTIFICATION

the Administrator whose decisions are final and binding. The Grand Prize drawing will be conducted on October 8th, 2018. 6. CONDITIONS ATTACHED TO THE PRIZE

PERSONAL INFORMATION

- From time to time, the Organizer, with the Entrant’s consent, may use the personal information provided for the purpose of:
 - Communicating with the Winner so he/she can take possession of the Prize;
 - Communicating with the Winner directly in relation to goods and services offered by the Organizer, including special offers and information on travel services; and
 - Conducting a survey regarding the effectiveness of the website, advertising and sales efforts made by the Organizer.

8. PRIZE CLAIM

- By accepting the Grand Prize, the Grand Prize Winner agrees to release and hold harmless the Promotion Entities, each of their related companies, and each of their

respective officers, directors, employees, shareholders, and agents from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of the prize in question.
